ORDINANCE NO. 2010- 02

**AN ORDINANCE AMENDING THE CODE OF THE BOROUGH
OF EAST GREENVILLE BY ADDING A NEW SECTION TO
CHAPTER 47, "GARBAGE AND REFUSE DISPOSAL",
NUMBERED 47-17, ENTITLED "FEES, PENALTIES, DISCOUNTS
AND DELINQUENTS. "**

BE IT ORDAINED and enacted by the Borough Council, and it is hereby ordained and enacted by authority of the same as follows:

SECTION 1. The Code of Ordinances of the Borough of East Greenville is amended by the addition of a new Section to Chapter 47 and entitled "Fees, Penalties, Discounts and Delinquents."

§ 47-17. Fees, Penalties, Discounts and Delinquents.

A. The fees for the collection or disposal of refuse and penalties for late payment shall be determined from time to time by resolution of the Borough Council of the Borough of East Greenville; public notice of the fee schedule shall thereupon be made. The initial fees are set as follows:

1. As of the tax year 2010, a yearly fee per dwelling unit of \$113.00 shall be due, payable on or before March 1st. If paid after March 1st, the per dwelling unit fee due shall be \$135.00.

2. In addition, the cost per East Greenville Borough garbage bags shall be modified to \$1.00 per bag.

3. This ordinance shall be effective thirty (30) days after being adopted.


B. All bills for the collection and disposal of refuse shall be rendered annually and shall thereupon be immediately due and payable. All bills shall be payable to the Borough Secretary. Payments representing collection costs for January through December shall be subject to a per-dwelling-unit penalty if not paid on or before March 1. Accounts not paid within 60 days of March 1 shall be referred to the Borough Solicitor with instructions to proceed for the collection of such unpaid charges, together with all penalties thereon, and the same shall be collected by an action of assumpsit in the name of the borough against the owner of the property charged or by a lien filed in the

nature of a municipal lien against the subject property or in any other manner provided by the law for the collection of a municipal lien.

SECTION 2. The Code of Ordinances of the Borough of East Greenville is Amended by the modification of Chapter 47 Section 16 entitled "Violations and Penalties" to read as follows: Except for the provisions provided for in Chapter 47 Section 17 Any person who shall violate any provision of this Chapter shall upon conviction thereof be subject to a fine of not less than \$100.00 nor more than \$1,000.00, or imprisonment for a term not to exceed 30 days, or both, at the discretion of the Court.

SECTION 3. The above-said amendment to the Code of Ordinances of the Borough of East Greenville shall become effective immediately upon adoption.
